H. 171 An act relating to restrictions on the use of electronic cigarettes

H. 571 An act relating to driver's license suspensions, driving with a suspended license, and DUI penalties <http://legislature.vermont.gov/assets/Documents/2016/Docs/BILLS/H-0571/H-0571%20As%20Introduced.pdf> This bill proposes to:

- (1) require the establishment of indigent waiver penalties for traffic violations and the imposition of the indigent waiver penalty in lieu of the 10 general waiver penalty for a defendant who applies and qualifies as indigent;
- (2) prescribe the criteria to qualify as indigent;
- (3) require judgments for traffic violations to be reduced by one-half if the defendant applies for the reduction prior to initiation of contempt proceedings and qualifies as indigent;
- (4) reduce the duration of license suspensions for nonpayment of a judgment on a traffic violation;
- (5) repeal a provision requiring the Commissioner of Motor Vehicles to refuse to renew a motor vehicle registration for nonpayment of an amount due on a judgment for a traffic violation
- (6) eliminate reinstatement fees for license suspensions and other preconditions to reinstatement, and authorize an additional surcharge on all traffic violation judgments to be deposited into the Transportation Fund;
- (7) amend the law governing criminal penalties for driving with a suspended license or privilege to operate and authorize criminal penalties for a second or subsequent violation of driving without a license or permit;
- (8) increase authorized penalties for DUI violations; and
- (9) clarify who will qualify for expungement of past criminal convictions for driving with a suspended license for conduct that is no longer criminal under this act.

S. 14 An act relating to single dose, child-resistant packaging and labeling of marijuana-infused edible or potable products sold by a registered dispensary <http://legislature.vermont.gov/assets/Documents/2016/Docs/BILLS/S-0014/S-0014%20As%20Introduced.pdf> This bill proposes to require that marijuana-infused edible or potable products be contained in single dose, child-resistant packaging and be labeled with the amount of tetrahydrocannabinol in each dose. The act also makes a technical amendment to the definition of registered caregiver to conform to 2014 amendments to the chapter. S. 243 An act relating to combating opioid abuse in Vermont

<http://legislature.vermont.gov/assets/Documents/2016/Docs/BILLS/S-0243/S-0243%20As%20Introduced.pdf> This bill proposes to increase the frequency with which health care providers query the Vermont Prescription Monitoring System when prescribing opioids to their patients. It would require the Commissioners of Health and of Public Safety to establish a statewide prescription drug disposal program. The bill would seek to increase the number of prescribers of buprenorphine to patients with a substance use disorder by encouraging care coordination with primary care providers, establishing a telemedicine pilot program, and requiring insurance reimbursement for certain pill counts conducted by pharmacists. It would also increase the amount of continuing medical education certain physicians must complete on the topic of prescribing controlled substances, including education on the use of complementary and alternative therapies instead of opioid controlled substances in treating chronic pain.
