This bill proposes to allow law enforcement to use saliva testing on operators of motor vehicles reasonably suspected to be drug-impaired.

#### H.599 An act relating to games of chance organized by nonprofit organizations

This bill proposes to permit a nonprofit fraternal organization to organize and execute games of chance that are only open to members, in which all of the proceeds are awarded as prizes; to clarify the definition of “casino event”; and to require the Attorney General to create educational materials regarding gambling activities in which nonprofit organizations are permitted to engage.

#### **H.8 An act relating to distracted driving**

**This bill proposes to**

- (1) require the assessment of points against a person's driving record for violating the law prohibiting handheld use of a portable electronic device while driving if the offense occurs in a school zone;
- (2) require the assessment of points against a person's driving record for a second or subsequent violation of the law prohibiting handheld use of a portable electronic device while driving;
- (3) require that an oral or written license examination administered by the Commissioner of Motor Vehicles test the applicant's awareness of the dangers of distracted driving;
- (4) require the Commissioner of Motor Vehicles to recall a minor's learner's permit or junior operator's license for 30 days following a second or subsequent conviction of violating the law prohibiting handheld use of a portable electronic device while driving;
- (5) amend the law creating the State's DUI Enforcement Special Fund in order to rename the Fund and expand the purpose of the Fund to include expenditures to support enforcement of the State's distracted driving laws, and make related conforming changes.

It would remove health insurance benefits from the bargainable subjects for public employees who are subject to a collective bargaining agreement and instead specify that employees who wish to have health insurance coverage would be covered under the public option.

**H.170 An act relating to possession and cultivation of marijuana by a person 21 years of age or older**

**This bill proposes to** remove all criminal and civil penalties for possession of two ounces or less of marijuana and cultivation of two mature marijuana plants and seven immature marijuana plants for a person who is 21 years of age or older; adjust the civil and criminal penalties for possession and cultivation of marijuana in amounts in excess of the legalized amounts; establish civil penalties for consuming marijuana in public and cultivating marijuana in a manner that is not on property lawfully in possession of the cultivator or without the consent of the person in lawful possession of the property or outside an enclosure that is screened from public view; establish criminal penalties and a civil action for damages for furnishing marijuana to a person under 21 years of age; and establish a crime of chemical extraction of marijuana.

**This bill proposes to** add post-traumatic stress disorder to the list of qualified medical conditions for therapeutic use of cannabis and to waive the three-month professional–patient relationship requirement for veterans diagnosed with post-traumatic stress disorder, provided the patient has a documented diagnosis from the U.S. Department of Veterans Affairs.

**This bill proposes to** establish statewide access to drug and DUI treatment courts programs operating in compliance with national best practice standards by 2022 by:

- (1) finding that national data reveal drug and DUI court programs deliver a high return on investment and currently there is only one DUI Treatment Docket operating in the State;
- (2) creating the Drug and DUI Treatment Courts Grants Board to assist counties in establishing treatment court programs compliant with best practice standards and to administer grant monies in support of these programs across the State;
- (3) directing the Chief Administrative Judge to recommend a rollout schedule for providing statewide access to treatment court programs within the next five years;
- (4) requiring joint reporting by the Drug and DUI Treatment Courts Grants Board and the County Drug Court Coordinator on the rollout of the treatment courts in 2019;
- (5) establishing the Drug and DUI Treatment Courts Special Fund; and
- (6) imposing a surcharge on the cost of obtaining a criminal history or conviction record to assist in funding statewide access to drug and DUI treatment courts.
